1. COSA È L'ERASMUS+ BIP

The Erasmus Blended Intensive Programme (BIP) is a new short-term intensive mobility option envisaged by the new Erasmus+ 2021-2027 programme. Using innovative teaching and learning approaches, it offers an international experience that combines short-term physical mobility with a mandatory virtual component.

Description	The project "Literary landscapes of Schleswig-Holstein" aims to analyze the literary works of Schleswig-Holstein authors. The focus will be on Storm, Liliencron, Hebbel, the Mann brothers, Grass, Kirsch, but also more recent authors such as Berit Glanz. Innovative (digital) methods of teaching will be used to promote collaborative learning and research. The results of the joint work in the seminar will be presented to a wider audience of scholars/s in a workshop at the end of the semester. The literary spaces examined will be interpreted and experienced during the excursions in the area



3. WHO CAN APPLY

Application requirements are listed below:

1. Being regularly enrolled at the University of Milan for the 2022/2023 academic year, on the Foreign Languages and Literature (L-11) or European and extraeuropean languages and literatures (LM-37).
or
2. Being regularly enrolled on Linguistic, Literary and Intercultural Studies in European and Extra-European Perspectives
3. Being current with tuition and fee payments
4. Not being a recipient of any other EU grant for stays abroad that overlap, even partially, with the BIP Erasmus+ period

4. APPLICATION

To apply, register on the elixForms platform by 2 pm on February 28th 2023

The following documentation is required:

- 1) A paragraph explaining the reasons for the application in relation to the BIP's learning objectives (to be entered in the appropriate field of the online application form);
- 2) Signed CV and copy of ID (PDF/A file; max 5 MB);

BA and MA students have also to upload

- 3) Self-certified transcript of records (to be printed from Unimia as a PDF/A file; max 5 MB);

5. SELECTION PROCESS

A Rector-appointed board will select up to 8 students and 3 PhD students based on the following criteria:

- a) Academic career and CV (up to 10 points);
- b) Language skills (up to 8 points);
- c) Candidate's motivation (up to 12 points).

The language skills will be evaluated during the interview.

The **online interview** will take place on **14th March 2023 at 10 am** on the **Teams** channel.

6. BORSE DI MOBILITÀ

Two types of grant may be awarded to help BIP students during their physical mobility period:

- an individual BIP mobility grant of €70 per day;
- a travel grant based on geographical distance and corresponding Erasmus rates of €275.



All admitted students who will complete the physical and virtual mobility programme will be eligible to these grants.
