1. WHAT IS THE ERASMUS+ PROGRAMME

The Erasmus+ Mobility for Study Programme supports the transnational mobility of students by providing funding study-abroad experiences, including attending courses, exams, thesis research, conducting research, laboratory and clinical activities. Full recognition is guaranteed for all activities successfully completed at the Host University and previously approved by the Home University.

The University of Milan upholds the values enshrined in the European Charter for Higher Education, guaranteeing equal access, transparent procedures, and support for participants with fewer opportunities. It also promotes inclusion, endorses measures for the protection of the environment, strengthens European identity and encourages active citizenship

Based on the agreements with partner universities, the Study abroad period may last between a minimum of 2 months and a maximum of 12 months, over the period 1st July 2025 to 31st July 2026.

The countries participating in the programme are:

- The Member States of the European Union: Austria, Belgium, Bulgaria, Croatia, Cyprus, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden;

- As well as: Iceland, Liechtenstein, Norway, Republic of Macedonia, Serbia, Türkiye.

Moreover, this call for applications covers also study in the Swiss Confederation.

The University of Milan offers its students the opportunity to study at approximately 400 European universities. It also available campuses include in the 4EU+ Alliance respectively: Sorbonne Université, Université Paris-Pantheon-Assas, Charles University, Universität Heidelberg, the University of Copenhagen, the University of Warsaw and the Université de Genève.

Within the Alliance, the "Biodiversity, Ecology and Evolution" (BEE) Learning Pathway is available, offering the opportunity to select courses from a predefined package of exams available on the website (Flagship 4, "Environmental transitions"). These courses can be included in the Learning Agreement.

Students abroad will be registered with the Host University, which will not require them to pay any tuition fees (except any fees that are not enrolment-related). It is understood that **students shall pay the University of Milan's tuition fees for the relevant academic year** (2025/2026 for students selected under this call for applications).

2. WHO CAN APPLY

The following students can apply, depending on the agreements established with the partner universities:

- All students of the University of Milan who are regularly enrolled in Bachelor's, Master's and single-cycle Master's degree programmes, provided that they are not off track for more than one year at the time of application. Part-time students may apply in compliance with Erasmus+ regulations.
- Students enrolled simultaneously in two degree programmes at the University of Milan, which, at the time of application, shall specify the degree programme for which they are submitting the Erasmus+ application. In the event that a student is simultaneously enrolled in a degree programme at the University of Milan and another one at a different university, the mobility period cannot exceed 12 months per study cycle and cannot overlap with other mobility programmes.
- Students enrolled in their final year of undergraduate studies and who are about to graduate, not off track for one year at the time of application, and who intend to University of Milan International Mobility and Promotion Office Via Santa Sofia, 9 20122 Milan, Italy Contacts: Informastudenti > INTER Erasmus Study > Before the mobility





enroll in the first year of a Master's degree at the University of Milan in the reference year of the call.

All students must be **enrolled in a study programme of the University for the academic year 2025/2026** upon departure, and maintain this status during their period abroad.

Students enrolled at other universities are not eligible to apply.

Those who intend to undertake Erasmus+ study abroad during the first year of their Master's degree programme may start their stay only upon enrolment for the academic year 2025/2026. Pre-enrolment is not valid for this purpose. If enrolment in the Master's degree programme is completed at a time when the first semester of the 2025/2026 academic year abroad has already begun, the stay shall be postponed to the second semester of 2025/2026, even if this results in a shorter period as opposed to the number of months offered under the call. Students in this condition are therefore encouraged to prefer destinations with a semester-long duration and to indicate their intention to depart in the second semester at the time of application.

Students may participate in the Erasmus+ programme several times during each study cycle, provided that the overall duration of the mobility periods does not exceed 12 months per cycle or 24 months for single-cycle programmes. The 12/24 months cap includes both *Blended Intensive Programmes* (BIP) and *Traineeship* mobility.

Please note that for some study programmes the application for the Erasmus+ programme is subject to academic requirements (e.g. any minimum thresholds in terms of year of enrollment, the number of credits, failed exams/core exams passed or curricular languages). Students are invited to pay attention to Annex A, which is an integral part of the present Call, for further academic requirements.

3. LEARNING AGREEMENT AND CREDITS RECOGNITION

Based on the current University's regulation and Academic Senate's Guidelines, students will be awarded transfer credits for the activities carried out abroad in accordance with their Learning Agreement. A Learning Agreement is the official document to be approved by the student, the student's Home university and the Host institution. It confirms that the chosen educational activities are consistent with the study programme in which students are enrolled.

The number of credits to be earned abroad, as set out in the Learning Agreement, should be equal to the number of credits the student would achieve at the University of Milan in the same time period, specifically: 60 credits for a whole academic year, 30 credits for a semester, 20 credits for a quarter.

Students may modify their Learning Agreement during their mobility.





According to the Guidelines, students must earn at least 70% of the credits set out in their latest Learning Agreement. At the end of the study the Erasmus+ programme, students are required to submit a recognition request for all the credits earned abroad. The relevant academic bodies will deliberate on the recognition of the credits.

Students must submit a general learning agreement proposal for each of the chosen campuses, outlining the educational activities to be carried out abroad, in accordance with the objectives and contents of their degree programme and individual study plan. The learning agreement proposal must be drafted using Form 1 attached to this Call for Applications. The document provides the Selection Committee with useful elements to assess candidates' maturity and form the basis for their official Learning Agreement.

For a proper selection of the destination, students are encouraged to carefully consult any additional information available in the **online application under "Details"** > **"Note"** for each partner university, as well as to review the academic offer and specific requirements (linguistic, enrollment, course access) required by the foreign universities, if any. By accessing the application management system, each student can view the destinations available for the degree programme they will be enrolled in at the time of mobility.

Students are advised to visit partner universities' websites. Some Universities have restrictions to the academic offer available to Erasmus students. We invite all students to check their offer directly with the partner university they are interested in.

4. LANGUAGE SKILLS

All students applying for Erasmus+ must possesses adequate language skills. Specifically, a minimum of level A2 is required in the language(s) of study/work used at the chosen campus(es).

Language proficiency will be assessed under the Common European Framework of Reference for Languages (CEFR - <u>https://www.coe.int/en/web/language-policy/home</u>).

In order to check which working language is used at a specific University, students should visit their website and verify the academic offer.

Should courses be delivered in multiple languages (e.g. in the official language of the host country and in English or another language), students may meet the proficiency requirement in one language only, provided that they meet the second working language requirement within the deadline set by the Host university.

It is the student's responsibility to verify the language admission requirements for the campuses to which they are applying.

If the student chooses university campuses that offer educational activities in multiple languages of interest to the student - for example, in the official language of the host country and in English or another language - the required language skills may pertain to just one language, provided the required level in the second working language is achieved by the deadlines set by the host university.

Language skills of students enrolled in degree programmes in Languages, Language Mediation and Veterinary Medicine will be tested during the oral interview. Students of these degree programmes are required to fill out Form 2 annexed to this call and attach it to their application to self-certify their language skills.

Students from all the other areas must submit either:

1 - A language **certification** recognized by the University ; the list of recognized certifications is available at <u>https://www.unimi.it/en/study/language-proficiency/other-foreignlanguages-tests-and-courses</u>. Certifications obtained no more than **five years** prior to the application submission date are valid.

or

2 - A **CEFR language proficiency statement** obtained through the **University Language Centre - SLAM.** For the sole purpose of this Call for applications, SLAM's proficiency statements are considered valid when obtained no more than **five years** before the time of application.

or

3 - **The screenshot of the Unimia academic record** showing the CEFR level of the required language. The CEFR level listed in the academic record does not expire.

Students who are enrolled in <u>degree programmes entirely taught in English</u>, or who attend curricula taught in English, are considered to automatically meet their English language requirement up to the level required for admission to their degree programme. These students will have to self-certify their English-language proficiency using Form 2. Students with a higher language proficiency are required to prove it as set forth in Annex A for their study area.

Native-speakers must adhere to the same language proficiency verification methods required by this Call for Applications and adopted by their degree programme.





Students who do not hold the above certifications/statements can obtain a language proficiency statement free of charge with SLAM's services, according to the calendar available on: https://www.unimi.it/en/study/language-proficiency/language-tests-and-courses-mobility-calls .

Students interested in obtaining as SLAM certificate are encouraged to do so by the deadline of this call - February 28, 2025. Please note that students are allowed to register for only one test session per language. The certificate will be issued within a maximum of one week, allowing it to be uploaded into the application system by the deadline of this call.

Any statement issued by tutors or university professors will not be deemed valid for the purposes of applications. Likewise, any credits earned for language assessments that are not managed by SLAM or issued by other Universities will not be considered as a valid language certificate.

Students should be aware that Host Universities often require language skills higher than A2. For this reason, we invite students to double-check the requirements directly on host Universities' official websites.

Should higher language levels be required, students are expected to reach that level by the deadlines set by Host Universities.

5. APPLICATIONS AND DEADLINE

Applications must be submitted online at <u>https://www.unimi.it/en/international/study-abroad/studying-abroad-erasmus/how-take-part-programme</u> by selecting ''Application > Your application for Erasmus+'', from <u>4th February (3 pm) to 28 February 2025 (1 pm)</u>.

In case of technical issues or inability to access the online application procedure, the student must contact the International Mobility Office via Informastudenti - INTER Erasmus Study, attaching a screenshot of the encountered issue, at least 48 hours before the application deadline.

Seen the digital natur of the Inter-istitutional agreements in EWP (Erasmus Without Paper), in case a change to any agreeement is needed during the application period, the office will contact the candidates who have already applied to any destination involved.

Upon completion of the application form, the student must upload the following documents:

- 1) Photocopy of a valid ID or passport (PDF file, max. size 2MB) mandatory attachment
- 2) <u>CV and an academic transcript of records showing the grade for each passed exam</u> (document available in Unimia); Master's degree students must also attach their Bachelor's transcript of records showing their final degree's grade and passed exams; Master's students who completed their Bachelor's degree in another Italian or international university, also need to upload an academic transcript of records of the

previous career showing their degree and final grade. The curriculum may be drafted by using the Europass format (https://europass.cedefop.europa.eu/it/documents/curriculum-vitae) - other formats are also allowed- <u>mandatory attachment</u>

- 3) **Proposed learning agreement** as specified in point 3 above (Form 1 PDF file, max. size 10MB) <u>mandatory attachment</u>
- 4) **Documentation certifying language proficiency**, as required by the university for which you are applying to (to be uploaded as a single PDF file). For information on how to prove language skills, please refer to point 4 above <u>mandatory attachment</u>;
- 5) Any other documents considered useful for the purposes of the application, such as any certificates of study, research or work placement abroad, or other international experiences <u>optional attachment</u> (single PDF file, max. size 5MB).

Students are invited to make sure they have the above documents ready in the required format before starting the application procedure. Applications not completed by the stated deadline cannot be resumed and submitted at a later time.

6. SELECTION PROCESS AND RANKING LIST

Students can choose up to **three destinations** among the opportunities offered by their study programme, **consistently with their language skills and academic priorities**.

With the aim of digitalizing and simplifying the procedures, the 2025/2026 Erasmus Call processes automatically a ranking list through the mobility online platform 'Flame'nGO'.

Please note that the order in which candidates list destinations in their application represents a <u>binding order of priority to generate the ranking list</u>. Candidates are therefore advised to check the order entered before confirming the submission of the application.

Candidates will go through a merit-based selection by appointed Commissions, whose composition will be published before 07/03/2025 on

For students enrolled in Bachelor's, Master's and single-cycle Master's degree programmes, the candidate's academic career will be assessed based on the **Erasmus Index**, which takes into account the average grade and credits earned with reference to the year of enrolment. The scoring system goes from 0 to 15.

The Committee may assign <u>15 additional points</u> based on the following selection criteria:

1) Assessment of the candidate's proposed learning agreement;

2) Assessment of the candidate's **CV, current academic career and previous academic career** (see point 5 above);

3) Assessment of the candidate's **language skills,** as specified in point 4, possibly during the interview.

Candidates scoring at least 1 in each category, and thus with an overall score of at least 3/15 will be eligible for study in the chosen campus(es). Candidates falling short of the said minimum score will not be admitted to the programme, regardless of their Erasmus Index score.

Subject to the total score of 15 points that can be awarded, each Commission has the discretion to define the ranges for each evaluation criterion. These scores are published on the page https://www.unimi.it/it/internazionale/studiare-allestero/cerca-una-opportunita-internazionale/bando-erasmus-studio-2025/2026, in Annex A.

According to each area, Committees will either evaluate candidates' applications only, or the applications will be followed by an interview, based on the above-mentioned Annex A.

The date, procedure and location of the selection process (scheduled, unless otherwise specified, between March 7 and 14, 2025) are reported in the Annex A by each area.

Where required, participation in the interview is mandatory. Rescheduling is not permitted except in the following cases:

• Simultaneous participation in other mobility programmes promoted by the University, which must be communicated within 7 working days before the interview date to Informastudenti > Erasmus Study and to the President of the Commission via e-mail;

• Certified health reasons, communicated before the interview date to Informastudenti (category "INTERNATIONAL - Erasmus Study") and to the President of the Commission via e-mail.

Any rescheduling will take place according to the availability of the Commission and to the procedures it establishes, but in any case, no later than March 14, 2025.

After the evaluation of the Committees, the online platform will generate a merit-based ranking according to the total score achieved (Erasmus Index and evaluation of the Committee).

The algorithm that generates the ranking list works as follows:

- 1. The first preferences expressed by students are analyzed. Each destination considers a maximum number of students equal to the number of available spots, starting with the candidates who have the highest scores in the ranking.
- 2. Students who meet these conditions—i.e., those who are not yet assigned and have indicated the destination as their first choice—are assigned to the destination. At the same time, all other preferences with lower priority for these students become available for other candidates.
- 3. After the first cycle of first-choice assignment, the system considers the destinations that have become available and proceeds with the assignment based on the scores.
- 4. The system proceeds similarly for the assignment of second preferences and, at the conclusion of the assignment cycles, the third choices.

In case of a tie, the system takes into account the following parameters:

- 1. Credits earned as of March 3, 2025;
- 2. Weighted average as of March 3, 2025;
- 3. Minor age

To calculate the Erasmus Index, the system will consider grades and credits registered up to 03th March 2025.

Within one week of the day of extraction, students will be able to view their Erasmus Index score on the Unimia page.

The equation to calculate the Erasmus Index is available in Annex B.

Selected students will also receive a communication of the selection on their institutional email.

Within 5 days of the publication of the results, selected students can **accept** or **withdraw** their offered place within 5 working days starting from the date following the the results through the following link: <u>https://studente.unimi.it/erasmus-domanda/</u>

Failure to accept by the deadline will result in an automatic withdraw of the programme. In case of waiver, there is no reassignment to other destinations.

After the student accepts or withdraws from the assigned destination, it will not be possible to change the choice.

Eligible students who were not selected for any destination will be put on the **waitlist** for each destination they were eligible for.

After the first window for acceptance is closed, the online platform will generate a new ranking, reassigning any vacant places to eligible students on the waitlist. Students, summoned by ranking order, may choose whether to accept or waive a vacant destination within the second acceptance window. The students will be informed of the dates of this second acceptance window.

Once the second acceptance window is closed, students on the waitlist can take over until **16**th **July 2025**. Depending on host universities' deadlines, the dates of the mobility may vary.

The Office may consider, in agreement with the selection Committees and based on the languages declared in the application, further reassignments to any vacant seats for students who are eligible but not assigned any places. Any reassignments will be completed by July 16, 2025. In case of reassignment, the mobility will only take place in the second semester. For reassigned students, any annual-duration locations will be reduced to the second semester only. The students involved will be contacted by the International Mobility Office via their institutional e-mail address.

Following the publication of the first ranking list, students, within the peremptory deadline of 5 days, may submit any comments/complaints regarding the outcomes themselves via the

The updated ranking with any vacant seat allocation will be published at <u>https://www.unimi.it/it/internazionale/studiare-allestero/cerca-una-opportunita-internazionale/bando-erasmus-studio-2025/2026</u>.

Should the results of the selections be published after the deadline to send out nominations to the host university for the first semester of a. y. 2025/2026, nominations may be submitted only for the second semester of a.y. 2025/2026.

Selected students are required to:

- Fill in their final Learning Agreement online. This document sets out the study programme to be undertaken abroad, which must be agreed in advance with the Erasmus coordinator/tutor. Please refer to: https://www.unimi.it/en/international/study-abroad/studying-abroad-erasmus/your-mobility; in their Learning Agreement, students shall enter only courses offered by the Department / degree programme of the host institution for which a bilateral agreement has been signed.
- **Sign their mobility contract**, setting out the conditions for allocating the mobility grant. Details on how to draw up the contract will be provided after the selections.

In addition, the student must fulfil other formalities as required by the host university (filling in the application form, submitting language certifications/certificates, and any other requirements).

Students who are awarded a mobility opportunity have the possibility to retake the mobility test for the same language (according to the calendar available on the SLAM pages https://www.unimi.it/it/studiare/competenze-linguistiche/test-e-corsi-di-lingua-bandi-di-mobilita) if they achieved a lower level than what is required by the Host University to submit their application.

Non-EU students must also be aware that the activation of their mobility may be contingent upon obtaining a visa to enter the host country. Therefore, these students are advised to select semester-long mobility and choose to depart in the second semester.





After the University of Milan notifies the Host institution of the nominees following the selection process, it is the student's duty to inquire about the administrative requirements and deadlines as set by the host institution.

7. ERASMUS+ MOBILITY GRANT

Students selected under the Erasmus+ programme receive EU-funded grants.

Erasmus+ grants cover additional mobility costs, such as travel expenses and a higher cost of living in the host country. They are **not intended to cover the entire cost of study abroad**.

The monthly scholarship is set by the Erasmus+ National Agency, usually based on the cost of living in the destination country.

As a reference, please note that for the academic year 2025/2026¹ the monthly scholarships were assigned as follows:

Any changes to the above table based on national provisions will be promptly disclosed.

¹ The monthly amounts of the Erasmus scholarships refer to the funding under Call 2024, which these selections refer to - Key Action 1 (KA1) – CALL 2024 – Project no. 2024-1-IT02-KA131-HED-000213649 (project deadline: July 31, 2025). If deemed necessary, some mobilities may be funded under the project attributed to the Call 2025, whose funding details and regulations have not been disclosed at the time of the publication of this Call. Please note that the number of monthly scholarships for each position, as set out in the bilateral agreements stipulated with the host universities, resulting in the value of the mobility grant, is merely an indication.

The actual amount of the grant is linked to the actual period abroad, within the limit of the monthly payments as established in the agreements with partner universities.

The monthly grant based on the destination country must be multiplied by the number of full months abroad.

The monthly amount to be applied based on the destination country must be multiplied by the number of full months spent abroad. In the case of incomplete months, the financial contribution is instead calculated by multiplying the number of days in the incomplete month by 1/30 of the monthly unit cost, as calculated through the European Commission's platform (Beneficiary Module).

Recipients of an Erasmus+ grant may not receive other EU-funded grants for the same period. If you are awarded an Erasmus+ grant, you are required to check for any conflicts with other calls for funds for which you have applied or intend to apply.

Please note that the grants will be awarded up to the limit of the funds made available to the University by the Erasmus+ National Agency on behalf of the European Commission.

Should EU funds be insufficient to cover all mobility places, the University will announce grant-award criteria in due course.

Grants will be paid on La Statale Card. Therefore, selected students are required to activate their personal badge as a *Flash Up Studio La Statale* prepaid card. Further information is available at this page: <u>https://www.unimi.it/en/study/student-services/carta-la-statale-badge</u>

8. SUPPLEMENTARY GRANT FOUNDED BY MIUR AND UNIVERSITY FUNDS

In order to promote participation in the Programme by students who are in economically disadvantaged situations, in line with the principle of equal access promoted by the Erasmus+ Program, the community mobility grant can be supplemented for these students. The amount and the criteria for the allocation of supplementary contributions are determined annually by the University's Board of Directors.

The income position of students participating in the Erasmus+ programme will be determined based on the <u>ISEE-University certificates for the academic year 2024/2025</u>, as submitted according to the procedures and deadlines prescribed by the University of Milan for the <u>purposes of a reduction on the second instalment of tuition fees</u>. (See the 2024/2025 fee regulation at <u>https://www.unimi.it/en/study/bachelor-and-master-study/fees-and-how-pay-them/fees-current-academic-year</u>.)

Students who receive a tuition waiver, or who do not normally apply for an ISEE-University certificate, should - if selected - request the certificate within the above-mentioned <u>deadlines</u>, if they believe that their household financial situation results in an ISEE value that does not exceed Euro 50,000.

Please note that for <u>international students whose household resides and has their income</u> <u>abroad</u>, the fees for their second instalment is not calculated on the ISEE University value, but consists of a fixed second instalment amount based on the student's citizenship. Therefore, <u>these students are NOT required to submit their ISEE</u>. The international students falling under this category will be assigned their additional grant according to the predetermined income values linked to the group their country of origin has been assigned to, according to the University's <u>Regulation on Tuition and Fees</u>.

We provide below, for mere information purposes, supplementary-grant award criteria as deliberated during the academic year 2024/2025:

Supplementary-grant award criteria and amounts for Erasmus+ students selected for 2025/2026 will be defined by a resolution of the Board of Directors.

Please note that the supplementary grant cannot be awarded to Erasmus+ students who have been off track for more than one year. Moreover, the grant will be paid to entitled students University of Milan - International Mobility and Promotion Office

provided that they earn at least 70% of the credits set out in their study-abroad Learning Agreement.

9. FOREIGN LANGUAGE COURSES

In order to allow students who are selected for a mobility period to become proficient in the language of the destination country before and during study abroad, the European Commission delivers <u>online language courses</u> (through the Online Linguistic Support-OLS). Selected students will receive further details by the Mobility Office.

Moreover, the University Language Center SLAM organizes every year free intensive courses on campus in the following languages: English, French, Spanish, German, Portuguese.

10. STUDENTS WITH SPECIAL NEEDS AND FEWER OPPORTUNITIES

In order to encourage students with physical- or mental-health-related needs to participate in the programme, the Erasmus+ National Agency may award them an additional grant on top of the mobility grant to cover their higher expenses abroad. With the aim of making the Erasmus+ Programme more inclusive, additional contributions may be provided also to students with fewer opportunities. It will be the responsibility of the International Mobility and International Promotion Office to inform the selected students, in due time, about the criteria for allocation and the procedures for submitting the application to access these additional contributions, and to collect the applications.

11. DATA PRIVACY
