



INFORMATION AND CONSENT FORM FOR PERSONAL DATA PROCESSING FOR PARTICIPANTS IN THE CREATION OF PROMOTIONAL AND EDUCATIONAL MULTIMEDIA MATERIALS (pursuant to art. 13 of EU Regulation 2016/679)

Introduction

Pursuant to art. 13 of EU Regulation 2016/679 concerning the protection of individuals with regard to data processing and circulation, which repeals Directive 95/46/EC ("General Data Protection Regulation" or "GDPR"), the University of Milan, as Data Controller, informs participants in video productions and multimedia promotional and educational materials of the use of their personal data.

1. Data Controller and Data Protection Officer (DPO)

The Data Controller is the University of Milan, represented by the pro tempore Rector, Via Festa del Perdono no. 3, 20122 Milan, e-mail: supportodpo@unimi.it.

Pursuant to art. 37 et seqq. of EU Regulation 2016/679, the University has appointed as Data Protection Officer (DPO) Mr. Pierluigi Perri, c/o Department "Cesare Beccaria", Via Festa del Perdono no. 3, 20122 Milan, e-mail dpo@unimi.it.

2. Purpose and legal basis of data processing

Your data, including your name, surname, role or position held, telephone number, e-mail, voice and images (hereinafter "Data"), will be processed in order to contact you and produce photos (also accompanied by notes and/or captions that may contain information about you), videos and multimedia materials (hereinafter "Materials") to be used as promotional and educational tools regarding the activities of the University.

The Materials will be posted to the University portal and websites (ecosistema web Unimi), social networks (Facebook, Instagram) and on Youtube through the official account of the University and its structures. The Materials may also be used for publication in printed productions (flyers, brochures, dedicated publications, print advertisements, etc.).

The legal basis for data processing is the data subject's expressed, free and unequivocal consent.

You may or may not give your consent to data processing at your discretion. However, failure to give your consent will result in the impossibility of producing the Materials.

3. Processing methods

Data will be collected in compliance with the principles of relevance, completeness and not exceeding the purposes for which the Data is processed.

The personal Data provided is processed in compliance with the principles of lawfulness, correctness and transparency, provided for by art. 5 of the GDPR, also through IT and digital tools designed to store and manage the Data, and, in any case, in such a way as to guarantee security.

4. Categories of persons to whom the Data may be communicated or who may learn about the Data, and Data transfers abroad

The Data is processed by persons working for University offices who are authorized by the Data Controller, in relation to their functions and competences.

The Data may also be processed by natural or legal persons working as consultants or service providers for the University for the sole purposes of recording and editing services (e.g. videoconference support services, integrated services for campus buildings, professionals and consultants appointed by the Data Controller). In this case, such persons will be designated as Data Processors pursuant to art. 28 of GDPR.

This is without prejudice to the communication or dissemination of Data requested, in accordance with the law, by the Public Security Authority, by the Judicial Authority or by other public entities for purposes of defense, state security and investigation of crimes.

Inasmuch as posted to the University social accounts through the platforms of service providers (e.g. YouTube, Facebook, Instagram, etc.), the personal Data of the data subjects may be transferred to third countries. Data transfer is based on explicit and informed consent and is carried out in such a way as to provide appropriate and suitable guarantees pursuant to art. 46, paragraph 1, of GDPR.



5. Data retention

Your Data will be kept for three years from the publication of the Materials.

6. Rights of the data subject

Pursuant to arts. 15 to 22 of the GDPR, the data subject may exercise, if the conditions are met, the right to ask the Data Controller for access to their personal data, the rectification or cancellation of the same, data processing restrictions, by contacting the following: Data Protection Officer, Mr. Pierluigi Perri, c/o Department "Cesare Beccaria", Via Festa del Perdono no. 3, 20122 Milan - e-mail: dpo@unimi.it.

7. Right to lodge a complaint with a supervisory or judicial authority

Data subjects who believe that the processing of their personal data occurs in violation of GDPR have the right to lodge a complaint with the Data Protection Authority as required by art. 77 of GDPR or to file a petition before the appropriate judicial authority pursuant to art. 79 of GDPR.
