

REGULATIONS ON TUITION AND FEES, WAIVERS AND SCHOLARSHIPS ACADEMIC YEAR 2024/2025

Art. 1 – Scope

These regulations govern student tuition and fees, the criteria for total and partial waivers from tuition and fees, and the criteria for awarding scholarships for the academic year 2024/2025.

Art. 2 – Student tuition and fees

Student tuition consists of the single, all-inclusive annual fee set by the University, the regional tax for the right to higher education and the stamp duty.

In addition, there are fees regulated by the University for services provided at the request of students for individual needs.

Art. 3 – Bachelor's, Master's and single-cycle Master's degree programmes

For the purposes of enrolling in Bachelor's and Master's degree programmes, taxes and the all-inclusive annual fee shall be paid in two instalments in accordance with the terms and deadlines set forth in these regulations. As this is a single obligation, the payment of the first instalment gives rise to the obligation to pay the second instalment as well.

Bachelor's, Master's and single-cycle Master's degree programmes shall be divided into two tuition areas as set out in Annex 1, which is an integral part of these regulations.

FIRST INSTALMENT

The first instalment is €156.00 and consists of the following items:- regional tax for the right to higher education€ 140.00- stamp duty€ 16.00

Enrolment is finalised by paying the first instalment according to the terms and conditions provided by the calls for applications to Bachelor's and Master's degree programmes.

Students are required to renew their enrolment no later than 30 September 2024, by paying the first instalment via the dedicated service in their UNIMIA account.

Those who intend to transfer to another degree programme of the University have to renew their enrolment in the previous programme for the academic year 2024/2025, before applying for internal transfer.

Students who graduate within the third session of the academic year 2023/2024 and students who transfer to another university by the applicable deadlines, as set by resolution of the Academic Senate, are not required to renew their enrolment.

Late enrolment fees shall apply to students renewing enrolment beyond the deadline, as set out in the articles that follow.

Late enrolment fees are also charged to those who apply to sit the final exam within the third graduation session of the academic year 2023/2024, but fail to graduate and consequently enrol in the academic year 2024/2025 after the deadline.



SECOND INSTALMENT

The second instalment consists of the all-inclusive fee and varies according to the economic situation of the student's household, the type of enrolment and the programme tuition area. The parameters for calculating the second instalment are the following:

- 1. For on-track students and students who have been off-track for one year, tuition is free if the student's ISEE (Equivalent Economic Situation Indicator) is up to €30,000.00;
- 2. ISEE greater than €30,000.00 and up to €38,000.00: 3% rate to be applied to the difference between the student's ISEE and an ISEE of €25,000.00 (formula in table 2 for area A);
- 3. ISEE greater than €38,000.00 and up to €80,000.00: 3% rate to be applied to the difference between €38,000.00 and €25,000.00 plus 6.7% rate to be applied to the difference between the student's ISEE and €38,000.00 (formula in table 3 for area A);
- 4. For programmes in area B, a multiplication coefficient of 1.28 is applied (formula in table 2 for area B);
- 5. A multiplication coefficient of 1.50 is applied to students who have been off-track for two or more years, with a second instalment equal to a minimum of €200.00 if the ISEE is up to €30,000.00 (formula in tables 2 and 3);
- 6. If the ISEE is greater than €80,000.00, students are charged the maximum second instalment, as specified below:

Students enrolled in joint degrees that are governed by specific agreements with foreign universities and are administratively based at the University of Milan shall pay the fees set forth in the agreements with which the degrees in question were instituted. Therefore, the above-mentioned criteria for determining the all-inclusive fee do not apply to these degree programmes.

SECOND INSTALMENT PAYMENT DEADLINE AND PROCEDURES

Students must pay the second instalment by 31 January 2025 via their UNIMIA personal account, in the section dedicated to payments.

For all those who enrol by 31 December 2024, payment notices will be issued in two rounds, the first one in the second half of December 2024 and the second one in the first week of January 2025. For students who enrol after 31 December 2024, but no later than 31 March 2025, the second instalment will be payable as of April 2025, and the payment deadline will be 31 May 2025.

The maximum second instalment, as shown in table 1 above, is charged by default to all those who enrol for the academic year 2024/2025.

To obtain a reduction on the second instalment, students must request the ISEE University certificate by 16 October 2024.

RESCHEDULING THE SECOND INSTALMENT

If the second instalment is equal to or higher than €700.00, students may request that this amount be staggered in four monthly instalments, without interest. This applies only to students who enrol in a Bachelor's, Master's or single-cycle Master's degree programme by 31 December 2024. Rescheduling the second instalment is not possible for students enrolled in a postgraduate programme (vocational masters, advanced courses, PhDs, postgraduate schools).

Students can request the new instalment plan from the moment the second instalment is payable and no later than 31 January 2025, by accessing the online service for the payment of tuition and fees.

Once the request for rescheduling has been confirmed, it is no longer possible to pay the second instalment all at once.

Failure to pay the rescheduled instalments by 30 April 2025 will result in the instalment plan being cancelled. In this case, the student will be required to pay the second instalment all at once.



The instalments must be paid by the following deadlines:

- 1. 31 January 2025
- 2. 28 February 2025
- 3. 31 March 2025
- 4. 30 April 2025

The first instalment of the new plan will be payable as soon as the request for rescheduling is submitted. The second, third and fourth instalments will be available only after payment of the previous instalment has been received by the University.

Failure to pay any instalment will result in the student's academic career being immediately halted until the debt is settled.

The instalment plan will be cancelled and the student will be required to pay the outstanding amount all at once in the following cases:

- if the student pays any instalment by using a payment method which is different from the one made available by the University;
- if the student requests the ISEE University certificate, with an update of the second instalment amount, after 31 January 2025.

If the fourth and last instalment is paid after 30 April 2025, a second instalment late payment fee will be charged to the student, and his/her academic career will be halted.

If a student ceases his/her studies at the University of Milan (withdrawal from studies, transfer, graduation), the instalment plan will be cancelled, and the student may formally end his/her academic career only after paying the full amount of the second instalment, including the late payment fee, if applicable.

Art. 4 – Part-time enrolment

As regards tuition and fees for part-time students, please refer to the University's Student Regulations – Appendix 3. Applications must be submitted between 1 October and 4 November 2024.

Students who want to enrol part-time must pay the first tuition instalment in full.

The second instalment amount is reduced by 50% or 25% depending on the part-time enrolment option.

Any decision to return to full-time enrolment shall be retroactive: if a student opts out of part-time enrolment, he/she will be required to pay the amounts not paid when he/she was enrolled part-time. If the student switches from full-time to part-time enrolment, there will be no refund of tuition and fees paid for previous academic years.

If the student graduates earlier, as compared to the duration of their part-time track, the second instalment amounts for part-time years shall be adjusted accordingly.

Students who apply for part-time enrolment after the second instalment payment notice has been issued may not apply for a rescheduling.

Art. 5 – Bachelor's degree in Computer Systems and Networks Security - Online

Those enrolled in this online programme must pay an additional fee amounting to €500.00 for on-track students and €200.00 for off-track student, to use the programme platform. This amount must be paid by 30 November 2024 and cannot be rescheduled.

The additional fee is due even if the student suspends his/her studies.

Failure to pay the fee by the deadline will result in the student's academic career being immediately halted, with no access to the platform.

Part-time students shall pay the full amount of the additional fee for the first three academic years, but will be exempt from paying it for the following academic years envisaged in case of part-time enrolment.



Art. 6 – ISEE Certificate for Education Incentive Programmes

The ISEE certificate for education incentive programmes, hereinafter referred to as ISEE University certificate, is required for students to receive a reduction on the second instalment, apply for financial aid and benefits based on economic conditions, and obtain the income score for the purposes of 200-hour student collaborations.

ISEE University certificates are acquired by the University online, from the INPS database. The University acquires only ISEE certificates for education incentive programmes. ISEE University certificates are not acquired online if:

- they have not been requested for education incentive programmes
- the student has already requested a rescheduling
- the student has already paid the second instalment.

To obtain a reduction on the second instalment, students must request the ISEE University certificate by 16 October 2024. Students holding an ISEE University certificate valid until 31 December 2024 do not have to request a new certificate.

The University also accepts ISEE University certificates requested between 17 October 2024 and 31 December 2024, but in this case the student will be charged a late declaration fee of €250.00. Only students who have not requested the ISEE University certificate by 16 October 2024 and have not paid the second instalment (either fully or in part) may consider this extended deadline.

A student has no right to a refund if his/her ISEE University certificate is exceptionally acquired after the payment of the second instalment (either fully or in part), and the amount due is below the one that the student has already paid.

The late declaration fee is not charged to students enrolled in Year I of a Master's degree programme who request the ISEE University certificate between 17 October and 31 December 2024.

Those who fail to request the ISEE University certificate by 31 December 2024 will be charged the maximum second instalment amount.

Students who apply to sit the final exam by the third graduation session of the academic year 2023/2024, but then fail to graduate and consequently have to enrol in the academic year 2024/2025, are required to comply with the deadlines regarding the ISEE University certificate and will be charged the late declaration fee.

CURRENT ISEE

For the purposes of a reduction on the maximum second instalment, students holding an ISEE University certificate may request the current ISEE certificate by the above-mentioned deadlines.

The current ISEE certificate must be requested within the terms set forth by these regulations, and must be valid at the time of acquisition by the University.

For the purposes of compliance with the deadlines and the application of the late declaration fee, the University will take into consideration the date of signature of the Single Substitute Statement (*Dichiarazione Sostitutiva Unica*, DSU) for the previous ordinary ISEE University certificate, to which the current ISEE refers.

SPECIAL CASES

Students not living with their parents

In application of art. 8 of Prime Minister's Decree (DPCM) no. 159/13, students who do not reside with any of their parents may declare themselves independent from their family of origin and request an ISEE University certificate in which they appear without their parents, if at the date of signature of the DSU both of the following requirements are met:



a) The student's residence, as resulting from personal data records, has been outside the housing unit of the family of origin for at least 2 years prior to the date of signature of the DSU, and in a property not owned by a member of the family of origin;

b) The student's income from employment or similar work, though not on a family member's payroll, as declared in his/her tax returns for calendar years 2022 and 2023, is not less than €9,000.00 per year.

In the case of married students, the minimum income requirement is assessed also including the income of the spouse. Therefore, married students may request an ISEE University certificate referred to their whole household, provided that the other applicable requirements are met.

Students who fail to meet one or both requirements will be considered part of their parents' household for the purposes of the ISEE University certificate.

If the request for the ISEE University certificate is submitted in calendar year 2025, the income requirements must be met in reference to calendar years 2023 and 2024.

Art. 7 – Tuition fees for students with foreign citizenship

Pursuant to art. 8 of DPCM no. 159/13, students with foreign citizenship and with a family that generates income and assets abroad cannot request the ISEE University certificate. These students owe a fixed second-instalment amount as set out below, based on their country of origin and the type of enrolment.

Amounts for on-track students and students who have been off track for one year – tuition area A €200.00 for students from Group A countries

€700.00 for students from Group B countries €2,000.00 for students from Group C countries

Amounts for on-track students and students who have been off track for one year – tuition area B €256.00 for students from Group A countries

€896.00 for students from Group B countries €2,560.00 for students from Group C countries

Amounts for students who have been off track for more than one year – tuition area A

€300.00 for students from Group A countries €1,050.00 for students from Group B countries €3,000.00 for students from Group C countries

Amounts for students who have been off track for more than one year – tuition area B

€384.00 for students from Group A countries €1,344.00 for students from Group B countries €3,840.00 for students from Group C countries

For the purposes of determining the fixed tuition fee, foreign countries are divided into three homogeneous groups, as set out in annex 2 (tables A, B, C), which is an integral part of these regulations.

Very poor and developing countries, as defined by an annual decree of the Ministry of University and Research, are shown in table A.

For students with Italian citizenship and foreign residence, and whose family generates income and owns assets abroad, the amount of the second instalment is established in reference to their country of residence.

For students enrolled in the Registry of Italians Living Abroad (*Anagrafe Italiani Residenti all'Estero*, AIRE) who qualify as "independent student" or whose family generates income and owns assets abroad, the amount of the second instalment is established in reference to their country of residence.



Students who have been granted political-refugee status are required to obtain an ISEE University certificate only if they have income or assets in Italy. If they do not, no document is required as proof of their economic situation, and the amount of tuition fees will be equal to the minimum amount. Moreover, the student will be allocated to the lowest-income bracket for the purposes of awarding any benefits under education incentive programmes.

Application for benefits under education incentive programmes

Students with foreign citizenship, and income and assets abroad, may apply for benefits under education incentive programmes if they meet the merit and need requirements specified in the respective calls for applications.

When submitting an application for a benefit, the student will be required to upload the documentation for the calculation of the equalised ISEE University value (*ISEE parificato*), for the purpose of determining the economic condition of the household. The list of any documents required and the rule for calculating the equalised ISEE University value are indicated in the specific calls for applications.

Moreover, these students may apply for tuition waivers, benefit from an automatic waiver in accordance with the provisions of these regulations and participate in the calls for student collaborations and other need-based benefits, based on the following ISEE assumptions:

Students from foreign countries listed in table A = 30,000.00

Students from foreign countries listed in table B = 35,000.00

Students from foreign countries listed in table C = 40,000.00

List of documents to be produced, if required, for the purposes of receiving benefits under education incentive programmes:

- Certificate issued by a registry office or other competent public body, according to the law of the country of origin, stating the composition of the household: if there is just one parent, the certificate must specify if the parent is separated/divorced, widowed, non-cohabiting (in this case, details of the other non-cohabiting parent must be provided);
- Documentation issued by the competent offices of the country of origin stating the income received in calendar year 2023 by all the household members (and specifying if the income was produced from employed work, self-employment, pension). If no income has been earned, the documentation must contain a declaration specifying the lack of income for each member of the household;
- Documentation issued by the competent offices of the country of origin attesting to the movable assets owned by all household members as at 31/12/2023: deposits, shares or investments securities, life insurance, the net equity of the corporation or business owned. If no movable property is owned by the family, the documentation must include a declaration attesting to the absence of movable assets for each household member;
- Documentation issued by the competent offices of the country of origin attesting to the immovable assets owned by all household members as at 31/12/2023, with an indication of the square metres of each property. The documentation must specify whether the property is the place of residence or otherwise. If no immovable property is owned by the family, the documentation must include a declaration attesting to the absence of immovable assets for each household member.

The documentation must be issued by the competent authorities of the country where the assets and income were produced, and must be legalised and translated into Italian by an Italian Diplomatic or Consular Authority abroad. For those countries where it is difficult to obtain the documentation from the local Italian Embassy, the student can contact the foreign diplomatic or consular authorities in Italy: in this case, the certification issued must be legalised by the Prefectures pursuant to art. 33 of Presidential Decree no. 445 of 28 December 2000.

Based on the documentation certifying the income/assets produced abroad, the University calculates the equalised ISEE University value by applying the following rules:



- sum of the income earned by each individual household member in the calendar year 2023;
- 20% of the sum of movable and immovable assets owned by each household member as at 31/12/2023; for the purposes of calculating the value of immovable assets, only buildings will be considered, and valued at €500.00 per square metre;
- the equalised ISEE University is calculated by adding together the above items and by applying the deductibles for income and movable and immovable assets and the equivalence scale set by DPCM no. 159/13.

Art. 8 – Provisions applicable to former students whose student status lapsed in the academic year 2023/2024

Former students whose student status lapsed in the academic year 2023/2024 and who renew enrolment in that academic year after the deadline must pay the first and second instalments plus the late enrolment fees.

In order to obtain a reduction on the second instalment, these students may submit the ISEE University certificate after the deadline, and will be charged a late declaration fee.

Art. 9 – Drop-out students

Students enrolled in the academic year 2024/2025 who withdraw from studies after 16 October 2024 and by 31 January 2025 are required to pay either a fixed charge of \leq 400.00 for withdrawal from studies or the second instalment in the amount based on their ISEE University value, whichever the lower. For those enrolled in Year I of a Master's degree programme, the fixed charge of \leq 400.00 is due if withdrawal occurs after 15 January 2025 and no later than 16 February 2025. If the student has already taken exams, this amount will be due even if withdrawal occurs before the dates indicated above. This does not apply to English language assessments.

Students enrolled in the academic year 2024/2025 who withdraw from studies after the above-mentioned dates must pay the maximum second instalment, or the amount due on the basis of the ISEE University certificate.

If a student withdraws after paying the second instalment (either fully or in part), he/she will not be entitled to receive any refund with respect to the €400 charge or the second instalment amount calculated according to the ISEE University value.

Students without an ISEE University certificate may request it beyond the deadlines set out in Article 6, with no late declaration fee. No late payment fee will be charged even if the payment is made beyond the deadline.

Drop-out students who fail to submit a formal application for withdrawal are also required to pay the second instalment.

Students who have applied for and obtained benefits under education incentive programmes may submit a formal application for withdrawal only after settling their debts.

Art. 10 – Provisions for students enrolled in postgraduate programmes

For postgraduate schools of medicine and health, the payment deadlines for the first and second instalments change according to the enrolment cohort.

For other schools, the second instalment is due on 31 May 2025.

Students who suspend their postgraduate studies for maternity or sickness leave are required to comply with the deadlines for enrolment and payment of the second instalment as contemplated for their cohort.

For the purposes of enrolment in postgraduate schools, tuition and fees are paid in two instalments but under a single obligation. Therefore, the payment of the first instalment gives rise to the obligation to pay the second instalment as well.

The second instalment is also due by students who drop out or formally withdraw from studies. If the application for withdrawal is submitted before the second instalment payment deadline, an amount of \notin 400.00 shall be payable as a fixed charge for withdrawal.

PhD programmes

PhD students must pay a \in 15.50 insurance premium, the regional tax for the right to higher education in the amount of \in 140.00, and a \in 16.00 stamp duty.

Vocational masters and advanced courses

For vocational masters and advanced courses, enrolment fees and the related payment deadlines are established each year by the academic bodies and specified in the calls for applications.

If withdrawal occurs prior to the actual start of the course, any fees paid will be reimbursed, minus an amount equal to 10% of the enrolment fee and in any case not lower than €100.00, which will be withheld by the University to cover general and administrative costs.

For the purposes of enrolment in vocational masters, tuition and fees are paid in two instalments but under a single obligation. Therefore, the payment of the first instalment gives rise to the obligation to pay the second instalment as well. The second instalment is also due by students who drop out or formally withdraw from studies. Rescheduling the second instalment is not permitted.

Postgraduate programmes are subject to the applicable provisions set forth in Articles 12, 13, 14 and 15 of these regulations.

Art. 11 – Fees for single courses

For enrolment in single courses, a fee of €180.00 is due for the first course and a fee of €126.00 for each additional single course.

The fees paid for single courses include the student's accident insurance and the stamp duty of 16.00.

Students with a disability equal to or above 66% and/or a recognised handicap pursuant to Law 104/92, foreign students enrolled at universities with which specific agreements are in place, foreign students who are participating in inter-university programmes, and recipients of scholarships from the Ministry of Foreign Affairs are exempt from course fees, but must pay the €16.00 stamp duty.

Art. 13 – Rules for the reimbursement of tuition and fees

The first instalment may be reimbursed only to students who renew their enrolment in the academic year 2024/2025 but graduate within the third session of the previous academic year, provided that they submit an application for reimbursement within 30 days of graduation.

The first instalment is not reimbursed to students who transfer to another university or withdraw to enrol at another university, except where a student withdraws to enrol in a capped programme after moving up in the ranking.

The first instalment is not reimbursed to students who receive benefits under education incentive programmes during the academic year 2024/2025 and graduate within the academic year 2023/2024. If the student is the recipient of a partial regional scholarship, he/she is required to pay 50% of the all-inclusive fee. If the student is the recipient of a partial University scholarship, he/she is required to pay



the entire all-inclusive fee.

The following are non-refundable:

- tuition and fees related to academic years prior to the year 2024/2025;
- application fees for admission to Bachelor's and Master's degree programmes, and to postgraduate programmes;
- the fee for enrolment in single courses;
- the fee for transfer from/to another university or programme, for enrolment in a second degree programme, for applying for simultaneous enrolment in multiple programmes, and for recognition of a degree obtained abroad;
- the second instalment, if it is higher than the amount due based on the ISEE University value which was acquired after the payment.

Applications for reimbursement must be submitted to the Student Offices (*Segreterie studenti*), along with a copy of the payment receipts of the amounts for which the refund is requested, and a declaration that the applicant has not received any benefits connected with his/her student status. The application for reimbursement must be submitted by the student in question or another duly authorised person, who will be required to produce an authorisation form signed by the student along with a photocopy of the student's ID.

If the application for reimbursement concerns deceased students, the following documents must be attached to the application:

- declaration in lieu of affidavit by which the applicant states that there is no will and lists all the legal heirs;

- power of attorney given by the heirs and authorising one of the heirs (or a third party) to submit the application and receive the reimbursement. Please note that the power of attorney must be authenticated at the local town hall.

From all types of reimbursement, the University withholds a €10.00 administrative fee, €2.50 to cover bank fees and €2.00 for the stamp duty (where applicable by law).

Art. 14 - Failure to pay tuition and fees

Students who are not current with the payment of tuition and fees for all the years of enrolment may not continue their academic career: they will not be admitted to exams or the degree examination, nor will they be able to transfer to another university or degree programme. They may not renew their enrolment in the academic year 2024/2025, obtain certificates, register for collaborations, apply for tuition waivers and scholarships, or submit any application for which student status is required.

Any examinations sat without being current with payments shall be cancelled by a Rector's provision. To withdraw from the University, and to receive any certifications for their academic records, students must be current on all past tuition up through the last year of enrolment.

Lapsed students may obtain certificates upon payment of any overdue fees up to the last year of enrolment.

In the case of serious health issues or the birth of a child, students may apply for interruption of studies before the second instalment payment deadline, by attaching documents attesting to the grounds for interruption. The amount of the first instalment already paid may be settled with the amount to be paid on resumption of studies. In any event, no refund may be granted.

The University of Milan will halt the student's academic career and start debt collection procedures against those who failed to pay tuition and fees or to repay any benefits that were subsequently cancelled.

Art. 15 – Tuition waiver

Tuition waivers may be granted automatically or upon request by eligible students, as described here below.



Automatic waiver

Full tuition waiver

- Students with a disability equal to or higher than 66% and/or a recognised handicap pursuant to art. 3, paragraph 1 of Law 104/92 who benefited from the same type of waiver in the academic year 2023/2024: these students will also have a waiver on the regional tax for the right to higher education; students enrolled in the online degree programme will also have a waiver on the related additional fee. - Students receiving total scholarships under education incentive programmes;

- Students receiving total scholarships under education incentive p
- Students receiving total University scholarships;
- Students with Ukrainian citizenship;

- Students of Bachelor's, Master's and single-cycle Master's degree programmes enrolled in the ordinary courses of the University School for Advanced Studies IUSS Pavia.

Partial tuition waiver (50%)

- Students receiving partial scholarships under education incentive programmes.

Partial waiver of €500.00 (to be deducted from the second instalment, if higher)

This partial waiver is granted to students who are enrolled on track in years subsequent to the first for the academic year 2024/2025, with a regular academic record, and have earned 90% of academic credits, as required by the Programme Description of their study programme up to the year prior to enrolment for the academic year 2024/2025, by 30 September 2024.

For students enrolled in Bachelor's and Master's degree programmes in the health professions and the single-cycle degree programmes in Medicine and Surgery, internship credits are assessed on 30 November 2024.

In the case of training activities spread over several years or more semesters with a single examination, all credits are understood as referring to the year in which the exam should be taken, as specified in the Programme Description.

The regularity of the academic record is assessed with reference to the level of the degree programme in which the student is enrolled in the academic year 2024/2025, considering the date of his/her first enrolment at University, with the exception of students with programme interruptions or repeated years and students who already hold another university degree.

Transfer students who have repeated a year are also entitled to this kind of waiver.

For students transferring from another programme of the University of Milan in the academic year 2024/2025, the 90% merit requirement refers to the number of credits required by their original programme.

For students transferring from another university in the academic year 2024/2025, or from another programme or university during an academic year prior to 2024/2025, the merit requirement refers to the number of credits required by the last programme in which the student was enrolled.

For all transfer students, a waiver may be granted only if the student has repeated a year no more than once throughout their career.

Part-time students are not entitled to the merit-based waiver requiring 90% of the credits.

Waiver upon request

Applications for a waiver must be submitted online from 2 November to 1 December 2024, after renewing enrolment in the academic year 2024/2025, and after requesting the ISEE University certificate (if specifically required for the waiver sought).

Full tuition waiver for students receiving scholarships from the Ministry of Foreign Affairs



Full tuition waiver for on-track graduates

Students who complete their studies within the statutory number of years as of the date of first enrolment, without enrolling as off-track or repeating students, and graduate with a final mark of 110/110, will be entitled to a full waiver on the all-inclusive fee for the last year of enrolment, provided that their ISEE University value does not exceed $\leq 40,000.00$.

This type of waiver is not available for graduates who have obtained transfer credits from a previous career, with the exception of graduates who were previously enrolled in a degree programme under the old regulations and had to opt into a degree programme under the new regulations.

The application for this waiver must be submitted within 30 days from the graduation date. Part-time students are excluded from this kind of waiver.

Waiver for disabled students with a disability equal to or greater than 66%

Students with a disability equal to or above 66% or a recognised handicap pursuant to Article 3, paragraph 1, of Law no. 104 of 5 February 1992 are entitled to a waiver on the all-inclusive fee and the regional tax. Students enrolled in the online degree programme also have a waiver on the related additional fee.

The application must be submitted exclusively by students who did not receive the same benefit in the academic year 2023/2024.

Waiver for disabled students with a disability lower than 66%

Applications are assessed by a special board, which will lay out the criteria for granting the waiver and the amount of the waiver, where applicable.

€100.00 reduction on the all-inclusive fee

This reduction is available to students whose household has more than one member enrolled at this University for the academic year 2024/2025, and an ISEE University value not exceeding €40,000.00.

The application must be submitted by each household member who is entitled to the reduction. This type of reduction can be combined with other waivers.

General Rules

The following general rules apply to the different types of waiver:

Students enrolled in postgraduate schools, PhDs, vocational masters and advanced courses may receive only waivers governed by national regulations, namely the waivers for recipients of scholarships from the Ministry of Foreign Affairs and the waivers for students with a disability equal to or above 66% and/or a recognised handicap pursuant to Law 104/92.

The regional tax for the right to higher education of \in 140.00 and the stamp duty of \in 16.00 are excluded from the scope of the waivers.

A waiver on the regional tax is granted to disabled persons with a disability equal to or greater than 66% and/or with a recognised handicap pursuant to Law 104/92.

Students benefiting from a waiver are required to pay any fees for late re-enrolment or late submission of the ISEE University certificate, and the second instalment balance, if due, by the respective deadlines, by accessing their UNIMIA personal account (section Payment Services).





Art. 16 – Income scores for the purposes of student collaborations

Art. 17 – Scholarships

The University provides the following types of scholarships:

- 1. regional scholarships under education incentive programmes;
- 2. 945 University scholarships of €1,800.00;
- 3. 60 scholarships and 100 full waivers from the all-inclusive fee for eligible non beneficiaries, reserved for international students and students holding a foreign degree who are enrolled in the first year of Master's degree programmes, or in the first year of the single-cycle Master's degree programme International Medical School;
- 4. 36 scholarships of €1,500.00, reserved for students enrolled in year I of a Bachelor's or singlecycle Master's degree programme who, after passing the relevant selection process, have enrolled in the ordinary courses of the University School for Advanced Studies IUSS Pavia, in accordance with the ad-hoc Agreement signed by the University of Milan, IUSS and the Collegio di Milano.

For the rules governing the first three types of scholarships, please refer to the respective calls for applications; for scholarships reserved for international students enrolled in the first year of Master's degree programmes, please refer to the relevant regulations issued by Rector's Decree.

Art. 18 – Tax inspections and penalties

The University of Milan will check the accuracy of the Single Substitute Statement (*Dichiarazione Sostitutiva Unica*, DSU) completed by students to obtain the ISEE University certificate for the purposes of claiming benefits under education incentive programmes, applying for University scholarships and receiving waivers (both automatic waivers and waivers upon request). The University will use any means at its disposal, including the tax register, to undertake any investigation it deems appropriate by requesting information to the State Financial Administration, the Cadastral Offices, and the Tax Police. Please refer to the regulations concerning the criteria for accuracy checks on Single Substitute Statements submitted for the purposes of claiming benefits from the University of Milan.

If data provided by the student does not match tax evidence or the findings of any checks carried out through Financial Offices and the *Guardia di Finanza* (Italian police force with economic and financial crime-fighting competences), the student will be required to pay the amount due based on his/her ISEE University value, and a penalty as provided for in the regulations concerning the criteria for accuracy checks on Single Substitute Statements.

Any false statements will be reported to the competent judicial authority.
